

Melt Privacy Policy

The Melt website is a Recurring payments and paid subscriptions management site. By using the Melt website, you consent to the data practices described in this statement.

Collection of your Personal Information.

Melt may collect personally identifiable information, such as your name. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by Melt. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Melt website.

Use of your Personal Information.
